**CORRIGENDUM**

Following pre-bid meeting held on 03.02.2025 in reference to e-NIT No. cited above, the below mentioned clarifications are hereby rendered in response to the queries raised by the prospective bidders during the meeting:

S. No.	Queries of prospective bidders	Clarifications
1.	Reduction of sales turnover from Rs.5 Crore to Rs.2 Crore for the last two financial years i.e. 2022-23 & 2023-24 in the relevant field.	Since, the queries raised would fundamentally impact the sanctity of the e-NIT which could lead to deviations from the original intent affecting fairness, transparency and compliance with established guidelines. Thus, <b>there shall be no change in the e-NIT conditions</b> in response to the queries from S.No.1 to 5.
2.	Deletion of <b>Clause- 3(III)</b> with experience of Manager / Chef.	
3.	Reduction of 02 functional Dhabas / Restaurants having a combined seating capacity of atleast 100 covers with 01 functional Dhaba / Restaurant having a seating capacity of atleast 50 covers.	
4.	Deletion of Evaluation <b>Clauses -5, 6 &amp; 7.</b>	
5.	The rates of items listed in Annexure-II shall be increased by 20%.	
6.	Specify the hard copy submission end date.	As per Clause-9 of the e-NIT, it is clarified that the hard copy of documents must be submitted by February 18, 2025 (upto 02:00 PM) This clearly defines the submission deadline, eliminating any potential confusion.
7.	Modification request in clause-3(IV) by replacing undertaking duly attested by 1 <sup>st</sup> Class Magistrate / Oath Commissioner with Geo-tagging for validity of information.	The revised clause-3(IV) of e-NIT would be: The firm must have atleast 02 functional Dhabas / Restaurants having a combined seating capacity of atleast 100 covers, operational for a period of atleast 03 years as on 31.12.2024. The bidder must provide FSSAI certification and Geo-tagging evidence to validate the presence of Dhabas / Restaurants in 02 or more states.
